## RESOLUTION #RES2020-12

**A RESOLUTION OF THE CITY OF DUNNELLON, FLORIDA, AMENDING CEMETERY FEES, INCLUDING OPENING AND CLOSING COSTS, INTERMENT RIGHTS, PROCESSING/ADMINISTRATIVE FEE AND TRANSFER FEE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, The City of Dunnellon owns, operates, and maintains the public cemeteries known as Dunnellon Memorial Gardens and Rockwell Cemetery; and

**WHEREAS**, the City Council of the City of Dunnellon desires to continue providing cemetery services; and

**WHEREAS**, the City Council has not amended the prices associated with the sale of cemetery property or services since 2017, and

**WHEREAS**, the City Council has determined it is necessary to increase prices associated with the sale of interment rights and services in order to ensure the financial stability and long-term perpetual care of the cemeteries; and

**WHEREAS**, the City currently processes cemetery sales by issuing a “Deed” to the purchaser. In consultation with local funeral homes and other cemetery operations, it has been determined that the sale should be treated as an “interment right” because the physical property is owned by the City; and

**WHEREAS**, the City Council has determined that future sales shall be considered interment rights, to include a fee for a second interment right, and shall be documented as such.

**THEREFORE BE IT RESOLVED** by the Council of the City of Dunnellon as follows.

1 The following Cemetery fees are hereby established:





Upon motion duly made and carried, the foregoing resolution was adopted by the City Council of the City of Dunnellon this 28th day of September 2020


