Pursuant to the City Charter, Section 8, Elections: No person shall be eligible to hold office who shall not at the time of his election be a qualified elector of said city, residing within the territory thereof; and in case any officer shall remove his residence beyond the limits of said city his office shall thereby immediately become vacant. In case any vacancy shall occur in any city office, such vacancy shall be filled by a majority vote of all the members of the City Council, and the person so appointed by the City Council shall hold office until the next annual or special election of officers and until his successor is elected and qualified.

**Public Officials appointed after December 31, 2023 are required to file FORM 6, Full and Public Disclosure of Financial Interests within 30 days of appointment and annually by July 1st for each year you hold office in order to avoid penalties by the State of Florida Commission on Ethics. Upon separation from the City Council, you are required to file FORM 6F Final Full and Public Disclosure of Financial Interests within 60 days of separation. Effective January 1, 2024, the Ethics Commission requires Form 6 filings must be completed electronically through the Commission website utilizing your City email.**

**Pursuant to the City Charter, Section 33, Oath: All officers of said city before entering upon the duties of their offices shall take and subscribe to an oath to faithfully perform the duties of their office.**

Your signature below indicates that you have read and understand the requirements for the public office for which you are applying, including the requirement to file a Full and Public Disclosure of Financial Interests. Your signature also indicates you have read and understand that Council members shall conduct themselves in a manner consistent with Resolution #RES2022-15, "City Council Code of Conduct" and Resolution #RES2013-17, "Public Code of Ethical Conduct," as may be amended from time to time.
