## **Existing Annual Inspection Fees and Information Sheet**

Please complete the existing annual fire inspection application to obtain an annual fire inspection. Annual fire inspections are only conducted upon request once a valid permit is secured from the City of Dunnellon. Examples of annual inspections include daycares, nursing homes, private schools, etc. Likewise, an annual inspection permit would be required for any business that wishes to have an inspection as required by insurance or licensing purposes. Once a permit is obtained, the annual inspection can be scheduled as soon as the next business day.
